

## **CRUSA FC BUCKS - TOURNAMENT WAIVER**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people over certain numbers.

Council Rock United Soccer Association Inc. and FC Bucks (collectively referred to as "the Club") has put in place preventative measures to reduce the spread of COVID-19 including but not limited to eliminating handshakes at the end of contests, the elimination of awards ceremonies at the end of tournament play, (we will mail them), elimination of tournament concessions, the insertion of gaps between game times and the requiring of masks to be worn by all non-participants, and participants except during active on field play; however, the Club cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending the Club events or programs could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume any and all risk that my child(ren), my family, and I may be exposed to or infected by COVID-19 by attending the Club events or programs and that such exposure or infection may result in personal injury, illness, permanent disability, or death. I understand that the risk of becoming exposed to or infected by COVID-19 at the Club events or programs may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Club employees, volunteers, and program participants and their families.

I understand that soccer is a contact sport and that athletes come into close contact with one another. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any and all injury to my child(ren), my family, or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s, my family's or my attendance at the Club or participation in Club events and programming ("Claims"). On my behalf, on behalf of my children, and family I hereby release, covenant not to sue, discharge, and hold harmless the Club, its employees, agents, officers, directors and representatives, of and from any and all Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating to COVID-19 or my child(ren)s participation in soccer at the Club or any of its facilities. I understand and agree that this general release includes any and all Claims based on the actions, omissions, or negligence of the Club, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Club program or event.

Further I represent that my child(ren), my family, and I have not traveled outside the Commonwealth of Pennsylvania within 14 days of our participating in the CRUSA FC Bucks Tournament to one of the states with a high amount of Covid-19 cases (see this link <a href="https://www.health.pa.gov/topics/disease/coronavirus/Pages/Travelers.aspx">https://www.health.pa.gov/topics/disease/coronavirus/Pages/Travelers.aspx</a> ) and that if we had so traveled, we would be self-quarantining and not participating in soccer activities sponsored by the Club.
